## **WORKERS' OBLIGATIONS<sup>1</sup>**

(art. 20 Legislative decree. 81/08 and subsequent modifications and integrations)

### TO BE HANDED TO THE INTERESTED PARTY DURING THE PERIOD OF TRAINING

1. Each worker is responsible for his/her own health and safety and that of others in the place of work who may be affected by the effects of his/her actions or failure to act, in line with his training and the means supplied by his/her employer.
2. Workers must especially:
  - a) contribute, together with his/her employer, managers and appointed individuals, to the fulfilment of the obligations in place to protect health and safety in the workplace;
  - b) respect the regulations and instructions issued by the employer, managers<sup>2</sup> and appointed individuals in order to protect the individual and group;
  - c) use correctly machinery, equipment, tools, substances, dangerous compounds, means of transport and other work equipment as well as safety devices;
  - d) use appropriately the protective apparatus made available to them;
  - e) report to the employer, manager<sup>2</sup> or appointed individuals any deficiencies in the apparatus and devices listed in c) and d), as well as other potential dangers they may be aware of, and intervene personally, where possible, in emergency situations in the scope of their assigned duties to eliminate or reduce such deficiencies or dangers, informing the workers' safety representative;
  - f) not remove or modify safety, warning and supervisory apparatus and devices without authorisation;
  - g) not undertake operations or manoeuvres on their own initiative that fall outside their assigned duties or that may compromise their own safety or that of other workers;
  - h) participate in theoretical and practical training programmes organised by the employer;
  - i) willingly undergo any work-related medical examinations or those arranged by the company physician.

<sup>1</sup> As well as the **university's professors, researchers, technical and administrative staff**, this also includes workers who may not be employed by the university and those from public and private contracted organisations that undertake work at the university, unless otherwise agreed, and also **university students, post-doctorate students, students taking specialist courses, interns, scholarship students, and those of equivalent status, when they are in teaching, research or service laboratories.**
